The Government of Kenya has applied for financial assistance from the International Development Agency (IDA) and Department for International Development (DFID) to support the Total War against AIDS (TOWA) project. The project contributes to the partnership against HIV and AIDS in Kenya by supporting the Government's program as articulated in the National HIV and AIDS Strategic plan (KNASP) 2005/06 to 2009/10. The Government intends to apply part of the proceeds of this Credit/Grant for Performance audit consultancy services. Sub-projects that meet relevant criteria will be funded for implementation by Civil Society, Private and Public Sectors through-out the country. About two (2) thousand sub-projects are expected to be approved and funded for implementation for each financial year starting from financial year 2007/08,. The main purpose of the Performance Audit consultancy services is to:

- To carry out performance audits on a sample basis to objectively verify that funded organizations actually implement activities in the approved work plans and that desired results as defined in the awarded proposals are actually achieved.
- To verify the accuracy of monitoring and evaluation data maintained and reported by the implementing organizations on the funded sub-projects.
- To develop the internal capacity within the National AIDS Control Council and its decentralized structures to assess and improve on the design, monitoring and evaluation of interventions to minimize risks.
- To ensure that prompt remedial action is taken to minimize risks in implementation of sub-projects
- To provide and document evidence that analyses the extent to which implementation of funded sub-projects achieves expected results and outcomes.

The assignment is for a period of twenty four (24) months with a possibility for an extension.

The National AIDS Control Council (the Client) now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they have the necessary qualifications and

capacity to perform the services. The information should include description of similar assignments undertaken and experience in similar conditions, availability of appropriate skills among core staff, availability of logistics, date when consultancy was established etc. The information should include names and addresses of at least 2 clients that the consultant has worked with in the past 2 years, and the specific assignments involved. Consultants may associate to enhance their qualifications.

A consulting firm will be selected in accordance with the procedures set out in the World Bank's **Guidelines: Selection and Employment of Consultants by World Bank Borrowers** (Published by the association in May 2004 Revised October 2006)
